
# Global Alcohol Policy Conference [#GAPC2023] welcomes Jacqui Drope to South Africa

#### 29 March 2023

**Cape Town:** Jacqui Drope, the director of the RESET alcohol initiative at Vital Strategies will be a panellist speaking on *New Initiatives in Promoting Impactful Policies and Reducing Industry Influence* at the upcoming 7<sup>th</sup> global alcohol policy bi-annual conference hosted by the Global Alcohol Policy Alliance (GAPA), the SA Medical Research Council (SAMRC) and the Southern African Alcohol Policy Alliance (SAAPA) along with its co-sponsors.

The conference takes place in Cape Town, South Africa from 24 – 26 October 2023.

Jacqui Drope is Director of the RESET Alcohol initiative at Vital Strategies that aims to reduce alcohol harms through alcohol policy for health, social, and economic gains. Jacqui has over 20 years of experience working with global partners to develop and implement strategic, actionable, and impactful public health policies and programs. Her focus has been on country-led, evidence-based interventions to prevent noncommunicable diseases (NCDs) with a particular emphasis on tobacco control, HPV vaccination, nutrition, physical activity, and cancer screening. Having worked with partners in over 25 low- and middle-income countries, Jacqui's experience is rooted in collaboration with a wide range of multisectoral stakeholders in governments, multilateral bodies, universities, non-profit



organizations, and medical professional societies. She actively seeks a diverse range of perspectives to help stakeholders achieve public health results.

From 2010-2020, Jacqui led the global cancer prevention program at the American Cancer Society where her programs contributed to comprehensive tobacco control legislation and increases in tobacco taxation and HPV vaccination coverage in countries in Africa, Asia, and South America. Jacqui has a unique mix of experience having worked in, and consulted for, various types of health organizations including the WHO Framework Convention on Tobacco Control Secretariat, Cancer Research UK, Johns Hopkins Institute for Global Tobacco Control, International Development Research Centre, Union for International Cancer Control, University of California San Francisco Center for Tobacco Control Research and Education, Health Canada, and the Senate of Canada.

The 7th bi-annual conference is co-sponsored by the Department of Social Development (DSD), the National Research Foundation (NRF), the DG Murray Trust and SA National Convention Bureau (SA Tourism). The bi-annual conference theme is "Investing in People before Profits: building momentum towards the Framework Convention on Alcohol Control".
