# Global Alcohol Policy Conference [#GAPC2023] welcomes Dr Rajesh Pandav as a keynote speaker

Cape Town: The Global Alcohol Policy Alliance (GAPA), the SA Medical Research Council (SAMRC), the Southern African Alcohol Policy Alliance (SAAPA) and the South African Department of Social Development, along with their co-sponsors, are excited to announce Dr Rajesh Pandav as a keynote speaker at the upcoming 7th bi-annual Global Alcohol Policy Conference (GAPC) to be held in Cape Town, South Africa from 24th to 26th October 2023.

Dr Rajesh Sambhajirao Pandav will speak on "Alcohol Marketing Regulation in Nepal: challenges and opportunities".

He has been appointed as the World Health Organization (WHO) Representative to the Federal Democratic Republic of Nepal since September 2020. Dr Rajesh's extraordinary service has been recognized by WHO. He was awarded the WHO Director General's Excellence Award in 2016. Under his leadership, WHO Country Office Timor-Leste was awarded the 2018-2019 WHO Director-General's Award for Excellence for championing the *Walk the Talk* initiative to promote physical activity.



Dr Pandav has authored several scientific publications. He received his MBBS degree from Grant Medical College, Mumbai, India; and a Master's in Public Health from the University of Pittsburgh, USA.

The conference theme is "Investing in People before Profits: building momentum towards the Framework Convention on Alcohol Control".

The 7th bi-annual Global Alcohol Policy Conference is also co-sponsored by the World Health Organisation (WHO), *Open Philanthropy*, and support from local sponsors including
